## **E-Rare-2 Joint Transnational Call (2014):** Muscular Dystrophy Canada (MDC) Story

 Patient organizations co-funding can be more fluid than national funders as their mandates are not always restricted to research being conducted within a specific country

MDC partnered with national funder in France & CIHR funded the work being undertaken in Canada

 Impact: allowed the funding of an additional grant which would otherwise not have been possible













# **Engaging Patient Organizations**

 EURORDIS/National funder reaches out to POs to establish interest in co-funding research projects within their organizations mandate



- Initiate as soon as possible to allow for POs to seek board approval
- Can become a partner up until the peer review of the full application
  - e.g., some POs may want to participate if there is a project within their mandate going to full application



# **Approach & Tools**

## Approach

- Method of communication depends on relationship with PO
- "Flexibility" is a key requirement when engaging with POs
- Robust communication strategy will be developed

## Tools

Two-page communication document (under development):

- E-Rare overview
- How to become a research partner



# Becoming a Research Funder on an E-Rare-3 JTC

Intent to Partner PO will confirm the area(s) of research interest, anticipated level of support, & primary contact through an *Intent to Partner* statement

## Coordination

Both the Intent to Partner Statement & the PO Funder table will be sent to EURORDIS who will work with the JTC Secretariat to coordinate with national funders in the overall JTC



# Areas of Interest:

## Advance research within a POs Mandate

## JTC Materials

POs will be asked to complete a table modeled after the JTC "funder table", in partnership with national funders (where appropriate)

It is in the "patient organization table" where POs will include information such as:

- Outline their areas of interest
- Indicate level of funding available & the duration
- Identify other terms/requirements/preferences as needed such as research must be conduct in XXX (name of country)
- Provide a contact name



## Review

## Timing

## **Relevance Review**

POs determine which applications are within their area of interest to fund through the review of anonymized one-page research summaries

Anonymized one-page research summaries will be provided at the full application stage. PO relevance review results must be finalized prior to the review of the full applications

**Coordination** EURORDIS coordinates the relevance review process & represents the POs at the E-Rare-3 CSC meetings



# **Finalizing Competition Results**

#### Applications are funded in rank order



EURORDIS will participate at the CSC meeting to develop the funding scenario on behalf of POs based on the relevance review results & anticipated level of funding



EURORDIS will confirm the funding scenario with POs & will connect them with the appropriate national funder



Collaborative Agreements are established with the national funder





## Benefits and Potential Impact of Co-Funding Research: ARSACS

#### **Economic value**

• When you are a patient organization for a rare disease raising funds is not an easy task. Partnering with CIHR enables a direct source of funding leveraged to the funds invested into research by the patient organization.

#### Public Awareness & Credibility Values

 Partnering with an important partner such as CIHR adds credibility to the organization's overall work with respect to the scientific and philanthropic communities. It also raises public awareness towards the specific rare disease.



## Benefits and Potential Impact of Co-Funding Research: ARSACS


#### **Scientific Value**

 Partnering brings together new researchers (nationally and internationally) and new participants such as pharmas to the existing research project. As a patient organization devoted to a rare disease, it can be difficult to reach out to new researchers and to new research projects nationally and internationally.

#### Hope Value


 Individuals and their families afflicted with a rare disease often feel isolated. Partnering with CIHR sends a message of hope to the families who are affected by the disease by letting them know that they are not left to themselves and that organizations are actively working together to improve their quality of life.






#### Joint Transnational Calls: CALL SCHEDULE

Funding commitment	The total amount available from CIHR-IG is \$500,000 (CAD) per year for a term of three years. The maximum amount that can be requested in support of a Canadian component is \$150,000 (CAD) per year for up to 3 years from all Canadian funding sources (CIHR-IG, Genome Canada, FRQS and their funding partners).
Anticipated number of fundable research partners	It is anticipated that funding will be available to support up to 6 to 8 from all Canadian funding sources (CIHR-IG, Genome Canada, FRQS and their funding partners). CIHR-IG is providing funding for up to 3 to 4 teams as outlined in the call text. Canadian funders will be working together to maximize participation from the Canadian research community

Submission of financial and scientific reports at the national level	Successful applicants funded through this funding opportunity and any other persons working on the project must comply fully with the <u>CIHR Funding Policies</u> (www.cihr-irsc.gc.ca/e/204.html). Policies and guidelines cover areas such as Applicant Responsibilities. Official Languages policy, Access to Information and Privacy Acts, and Acknowledgement of CIHR's Support.
